LATIN AMERICAN URBAN CULTURES

COURSE GOALS

This course surveys readings at the intersection of contemporary Latin American Studies, Urban Studies and Cultural Studies. This broad sweep through Latin American urban cultures focuses on five thematic kernels: transnationalization; creativity; memory; interculturalism; and sexualities. The course is intended for diverse audiences and majors from e.g. GEG, LAS, WGS, INS, COM, MLL, SOC, ANT, ARC and ART. While interweaving issues of class, race and gender in the discussion of all topics, seminar-style sessions will adopt spatial approaches cutting across multiple disciplines in social research and the humanities. We will particularly focus on place-making, circulations, boundaries, (de-re)territorializations and the re-mapping of the urban and the cultural in and beyond contemporary Latin America. The course combines focused readings with appreciation of films and other cultural products. Seminar participants are expected to gain a conceptual vocabulary; familiarity with research approaches; and extensive empirical exposure to Latin American urban cultures.

This is a participation intensive seminar, which is reflected in the grading policy. Attendance is not required (except for organized field visits) but highly encouraged for successful completion of assigned papers and required.
